Institute for cardiovascular diseases "Sv. Stefan" of Ohrid – Project CROSS4ALL announces the public call No.1 for engagement of the following administrative positions on the project:

- Position No.1 D1.6.2 **Project manager** one person, engaged 40 hours a month for a period of 18 months.
- Position No.2 D1.6.2 Financial manager one person, engaged 24 hours a month for a period of 18 months.
- Position No.3 D1.6.2 Administrator one person, engaged 64 hours a month for period of 18 months.

Project backround:

Institute for Cardiovascular diseases of Ohrid has been awarded in first call for proposals from the INTERREG IPA Program of the European Union for Cross-Border Cooperation between the Republic of Greece and the Republic of Macedonia 2014-2020. The title of the project is "Cross-border initiative for integrated health and social services promoting safe ageing, early prevention and independent living for all – CROSS4ALL".

The overall lead partner and first finantional partner of the project is the Aristotle University of Thessaloniki – Soecial Account for Research Funds – Department of Medicine. Institute for cardiovascular diseases Ohrid is a finantial partner number 6, and the other partners of the project are: Faculty of Information and Communication Technologies "St. Kliment Ohridski", Bitola (partner No.2); National Confederation of Diasabled People (NCDP), Greece (partner No.3); Mancipality of Ohrid (partner No.4); and Mancipality of Naples, Greece (partner No. 5. The implementation of the project started in April 2018 and is expected to be completed within 24 months.

Specific objective of the CROSS4ALL project is improving health care and social services for children and elderly. Target group of project activities are health and social workers and vulnerable categories of citizens.

CROSS4ALL workplan is based on the following main objectives:

- To foster health literacy and digital health literacy and promote self-management.
- To design innovative practices for improving access for vulnerabke goups and tackling health inequalities.
- To improve the capacity of health professionals and infrastructure to accommodate efficiently the needs of target group.
- To establish new mechanisms focused on the conditions of poverty, services of comfort and counseling at home, including in rural and isolated areas.
- To mobilize inactive individuals and unblock their potential in offering care to those most in need.
- To promote joint strategies for developing integrated healthcare and social care sans frontiers.

The project will also establish three pilot centers (one pilot in the Mancipality of Ohrid in collaboration with Institue for cardiovascular diseases with a mobile unit that will intervent in distant places from the city) for health and social protection which will contribute to improved and expanded services for the target groups, services for support that will help citizens to generate and maintain online accurate personal health records and maintain a common Help Desk for citizens and medical tourists.

In the frames of the project, Institute for cardiovascular diseases Ohrid should implement the following project activities: Organization of one-day Public Project Event (Opening Project Conference); organizing media campaign for prevention of cardiovascular diseases; Preparation of joint action plan and guide for status of health and social services in the myncipality and distant places; Elaborating and editing of special guide for people with disabilities and vulnerable groups; Organization of workshop for primary health and social care for health and social persons and citizens; Procurement, installation and maintenance of 1 set of medical equipment;

Procurement, installation and maintenance od 3 sets of medical equipment for a local pilot center for health and social protection that will provide health and social services to vulnerable categories of citizens in the city; Engaging a team of experts who will work in the local pilot center and in the mobile units; Organizing of 2 three day seminar in countries with similar experience with local pilot centers and mobile units;
